- c) Mary Maona -kitchen unit
- d) Personal clothes and jewellery to all the above mentioned grandchildren in equal shares.

At the burial, it was discovered that Tamary had also written a will bequeathing everything that she had to her husband and children. Tom and Tamary's parents feel that they should benefit from their children's estate since they are old and have no means of survival.
